Executive Director Chauvin stated the current cost per child for advocate services is \$840. She formally requested \$10,800 from the City of Diamondhead allowing the program to serve 12 additional children. Mayor Schafer thanked those CASA representatives and advocates present for their volunteer services to the community.

1. FY15 Budget Workshop –

City Clerk, Kristin Ventura, presented proposed fund allocations for FY15 Budget expenditures. Funds were also allocated for promotions and economic development and performance-based salary increases for employees. She explained the City's audit firm had reviewed and confirmed the projected advalorem revenue based on information provided by the Hancock County Tax Assessors Office and Council action is necessary at the August 5, 2014 Formal Meeting to accept the form and advertisement of the budget.




