I. **Presentation Agenda**

1. Council Comments

- a. The next regularly scheduled Council Meeting will be held at 6:00 p.m. CST on October 7, 2014 in Council Chambers located at 5000 Diamondhead Circle.
- b. Councilmember LaFontaine provided an update of the Solid Waste Authority. He also announced the Household Hazardous Waste Day will be held October 4th from 9:00 a.m. to 1:00 p.m. with the collection site located at Coast Electric Power Association in Kiln.
- c. Councilmember Knobloch announced Diamondhead Shred-It Day to be held at City Hall October 4th from 9:00 a.m. to noon. He also reported total number golf car decals issued to date recently reached 700. He also stated that officials from the Diamondhead Water & Sewer District toured City Hall earlier that morning.

2. City Manager’s Report

Paving work update: Mr. Sullivan is in the process of marking the roads for paving. The earliest the contractor will be available to begin is October 15th.

Improvement of the Dairy Queen Road: Mr. Tindell is working with an appraiser and reported survey work is underway and should be complete this week.

Drainage work beside City Hall: Engineering plans will be ready to review by next Wednesday, September 24th. If approved the advertisement and selection process will take about 60 days.

Stormwater Management Plan: The typographic surveying of all the drainage watersheds is complete and an inventory of existing stormwater facilities requiring an upgrade have been completed. Engineering analysis with recommendations has been completed and will be included in the Plan. The final Plan will be delivered October 15th.

Flag Pole: The pole will be erected next Wednesday, September 24th. An electrician will be here on the same day to install a light on the eve of the building to illuminate the flag at night. I suggest recognition at a Council meeting and a small plaque be added to the base of the flag pole to recognize and honor the donor.

Surplus vehicles: The Police Department received 2 (two) additional surplus Humvees to be used for storm rescue and recovery.

Kahala Assisted Living Facility: Plans have been submitted for review.

During Captain Al Hermann’s absence, Sergeant Roland Flowers will assume the tasks and duties beginning September 16, 2014.

Police Report provided by Sergeant Darrell Hughes. Sergeant Hughes reported the City has obtained a total three high-water vehicles for the City. The vehicles were obtained through DLS, Keesler Air Force Base, all recorded mileage less than 75 miles and were purchased at five cents on the dollar.

Janis Floyd addressed the Mayor and Council regarding proposed Resolution 2014-111- Support Exploration of the Interstate Re-Insurance Coastal Band. She urged a favorable vote in support of this initial step in a multi-state effort to restore affordable wind insurance premiums in the Gulf and Atlantic coastal counties.


The City Attorney announced that possible litigation matters were discussed in executive session and no official action was taken while in Executive Session.
