

**RESOLUTION AUTHORIZING EXPENDITURES
FOR INAUGURAL CEREMONY**

WHEREAS, a new term of office for the Mayor and Councilmember's of the City of Diamondhead is about to begin, and that event should be marked by an inaugural ceremony; and

WHEREAS, it is hereby found and determined that such a ceremony is a public event which brings into favorable notice the opportunities, possibilities and resources of the City of Diamondhead, serves as an advertisement for the City, and is helpful toward the advancing of the interests of the City; and

WHEREAS, Section 17-3-1 Section 17-3-3, and Section 21-17-5, Mississippi Code of 1972, as amended, authorize expenditures for public events such as an inaugural ceremony;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DIAMONDHEAD, MISSISSIPPI, THAT:

SECTION ONE: The findings, conclusions and statements of fact contained in the preamble of this Resolution are hereby adopted and ratified.

SECTION TWO: The City Manager, Municipal Clerk and the appropriate employees of the City of Diamondhead are hereby authorized to plan, prepare for, and conduct an inaugural ceremony to commemorate the new term of office of the municipal officials, and are further authorized to place a single ad in the Sea Coast Echo of 3 columns X 4 inches at the rate of \$162.00, provided that such expenditure shall be made in the same manner and by following the same procedures utilized for other municipal expenditures and further provided that all such expenditures shall be made in compliance with all of the purchasing, budgetary, and other applicable fiscal laws of the State of Mississippi.

SECTION THREE: That there shall be expenditures of up to \$300.00 to support the cost of the inaugural ceremony, and no other costs, fees, or expenditures shall be used for the event.
