

A RESOLUTION AMENDING THE SINGLE FAMILY RESIDENTIAL  
BUILDING PERMIT FEE FOR NEW CONSTRUCTION

A resolution of the Mayor and City Council of the City of Diamondhead amending the single family residential building permit Fee for new construction for a period of two years beginning as set forth in Ordinances 2012-009 and 2012-011 and respective exhibits attached thereto.

WHEREAS, the Mayor and City Council have reviewed the fee schedule for single family residential building permits for new construction as set forth in 2012-009 and 2012-011 and respective exhibits; and


WHEREAS, the Mayor and City Council have determined it necessary to suspend the current fee schedule for new single family residential building permits and to established said permit fee at a flat rate of \$1,200.00 for a period of two years beginning May 7, 2014 and ending May 6, 2016 with re-inspection fees during said period to be set at \$75.00 per occurrence for failure to comply with appropriate codes; and

WHEREAS, the Mayor and City Council have further determined the said fee shall become effective immediately and remain in full force for said period of time unless further Council action is taken.


NOW, THEREFORE, BE IT RESOLVED the Mayor and City Council of the City of Diamondhead do hereby amend as set forth in Ordinances 2012-009 and 2012-011 along with respective exhibits attached thereto, more specifically, the new single family residential building permit fee that shall be set at a flat rate of \$1,200.00 for a period of two years beginning May 7, 2014 and ending May 6, 2016 with re-inspection fees during said period to be set at \$75.00 per occurrence for failure to comply with appropriate codes for all pending and future applications and shall remain in full force and effect for the period so established unless further Council action is taken. All other fees set forth in Appendix A.1 through F - SCHEDULE OF PERMIT FEES FOR BUILDING of Ordinance 2012-011, as amended pursuant to Ordinance 2013-035, remain in full force and effect throughout the specified 24-month period prescribed herein.
