

RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF DIAMONDHEAD REQUESTING THE HANCOCK COUNTY BOARD OF SUPERVISORS APPOINT SCOTT THOMAS TO SERVE AS A COMMISSIONER FOR THE DIAMONDHEAD WATER & SEWER DISTRICT BOARD OF COMMISSIONERS

WHEREAS, a vacancy on the Board of Commissioners for the Diamondhead Water & Sewer District exists due to a resignation;

WHEREAS, a recommendation to the Mayor and City Council of the City of Diamondhead was received from Councilmember Ernie Knobloch and Councilmember Ron Rech for its consideration to recommend unto the Hancock County Board of Supervisors the appointment of Scott Thomas to fill the vacancy and unexpired term Charles Johnson on the Board of Commissioners for the Diamondhead Water & Sewer District;

NOW, THEREFORE, BE IT RESOLVED, the Mayor and Council of the City of Diamondhead do hereby concur with the recommendation of Councilmember Knobloch and Councilmember Rech and do request and recommend unto the Hancock County Board of Supervisors the appointment of Scott Thomas as Commissioner to be seated on the Board of Commissioners for the Diamondhead Water & Sewer District to fill the vacancy and unexpired term that which currently exists due to a resignation of Charles Johnson.
