

**AN ORDINANCE ESTABLISHING THE AMOUNT OF COMPENSATION FOR CITY OF DIAMONDHEAD ELECTION CLERKS, MANAGERS AND OTHER WORKERS**

WHEREAS, the City of Diamondhead holds its municipal elections pursuant to Mississippi Code of 1972, §23-15-173 and §23-15-857.

WHEREAS, the Mayor and City Council of the City of Diamondhead are to provide compensation for the work performed by clerks, managers and other workers pursuant to Mississippi Code of 1972, § 23-15-153, § 23-15-227, and § 23-15-229; and

WHEREAS, compensation for clerks, managers and other workers in the polling places of a municipality shall be the same as the compensation paid by the county for such services, unless otherwise provided for by statute specific to municipalities, and shall be paid out of the general fund;

WHEREAS, no additional benefits or additional costs shall be associated with the proposed compensation.

BE IT, THEREFORE, ORDAINED BY THE MAYOR AND CITY COUNCIL as follows:

Compensation for clerks, managers and other workers in the polling places for elections of the City of Diamondhead shall be the same as the compensation paid by the county for such services, unless such compensation shall otherwise be provided for by statute specific to municipalities, and shall paid out of the general fund

This Ordinance having been unanimously adopted shall be in full force and effect immediately upon passage pursuant to §21-13-11 and necessary to provide for proper compensation for such clerks, managers and other workers in the polling places at the impending special election called to fill the City Council Ward 2 vacancy with said special election to be held October 13, 2015.
