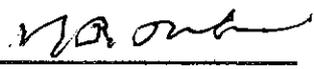
1. **Call to Order – at 1:30 p.m. by Chairman Thomas Sislow.**
2. **Statement of Purpose – read by Commissioner Parker.**
3. **Roll Call of Members- the following Commissioners were present: Denise Catone, Chuck Garrison, Nita Hensley, Jane Lee, Norm Parker, Roger Smith, and Thomas Sislow. Also present were Deonne Olier, Planning and Zoning Administrator, and Amanda Traxler, Planning and Zoning Attorney.**
4. **Confirmation or Adjustment of Agenda – none presented.**
5. **Approval of the Minutes – There were no corrections or additions to the minutes of the May 2, 2013, meeting they were approved as presented with motion from Commissioner Garrison and seconded by Commissioner Parker. Motion carried unanimously.**
