

A RESOLUTION AMENDING ZONING ORDINANCE 2012-019
ARTICLE 10: SIGNS AND OUTDOOR ADVERTISING

A resolution of the Mayor and City Council of the City of Diamondhead amending Zoning Ordinance 2012-019 Article 10: Signs and Outdoor Advertising.

WHEREAS, the Mayor and City Council have reviewed the existing Zoning Ordinance 2012-019 Article 10 Signs and have desired to amend and implement a revised Article 10 for the purposes of ease of use, interpretation and to promote economic development within the City; and

WHEREAS, the Mayor and City Council have contracted with and received from the Orion Planning Group a proposed Article 10: Sign and Outdoor Advertising to replace existing Zoning Ordinance 2012-019 Article 10 Signs; and

WHEREAS, the Mayor and City Council have pursuant to Zoning Ordinance 2012-019 Article 2.9.3, provided on May 2, 2015 the proper legal notice of the proposed amendment and public hearing along with notice of public inspection of documents with regards to Article 10: Signs and Outdoor via The Sea Coast Echo, a local newspaper of general circulation, and;

WHEREAS, the Mayor and City Council, after having provided proper legal notice as prescribed in Zoning Ordinance 2012-019 Article 2.9.3, have conducted a public hearing at its Formal Meeting held on May 19, 2015 at 6:00 p.m. in Council Chambers of City Hall.

NOW, THEREFORE, BE IT RESOLVED the Mayor and City Council of the City of Diamondhead do hereby adopt Article 10: Signs and Outdoor Advertising and thereby so amend Ordinance 2012-009 along with respective exhibits attached thereto.
