# 2. City Manager's Report

#### **East Aloha Drive Extension**

Please mark your calendar and plan to be at the intersection of Diamondhead Dr. and East Aloha Drive Extension for the official ribbon cutting and street opening this Friday at 3:30 p.m. I want to thank the Chamber of Commerce for organizing this for the City on short notice be we wanted to open the road as soon as possible.

#### Mardi Gras Parade

We received delivery today of the port-a-potties ahead of the parade scheduled for this Saturday, it was the only time we could get guaranteed delivery before Saturday. Captain Luther has been coordinating security with Sheriff Ricky Adam and Chief Don Bass. Public Works will have barricades out and a crew ready to clean up after the parade. The forecast for Saturday is sunny with a high of 68 degrees. We hope that families young and mature enjoy the parade.

#### Recycling

The Hancock County Solid Waste Authority did authorize the advertisement for curb side recycling. As soon as we receive bid I will let you know how the cost compares to the current arrangement.

#### Public Works

The Public Works crew has been addressing drainage and ditch concern, continuing to install new street signs, repainting existing stop bars and working on the paint truck to strip the newly overlaid streets. Annual maintenance of the grass cutting equipment is underway in preparation of the spring grass cutting season. Median cleaning and reseeding has the Diamondhead Drive medians looking alive with bright green winter grass.

#### **Public Safety**

There were a total of 426 calls in January including 131 traffic stops, 30 traffic citations issued, 40 suspicious person/vehicle calls, 29 animal problems, 30 false alarm calls, 4 reckless drivers and 1 suicide. There was an armed robbery of the Econo Lodge on January 2<sup>nd</sup> with approximately \$300 stolen from the desk clerk. Investigators are continuing to work that case. Captain Luther would encourage everyone to enjoy the Mardi Gras Parade, to arrive early and be patient with traffic, practice moderation and don't drive if you drink.
