Derek Cusick and Kelly Cash shall serve as independent contractors with compensation set a combined monthly rate of Three Thousand and 00/100 dollars..


The term of this contract is from July 24th, 2017, until August 31, 2018. The City of Diamondhead may terminate this agreement with thirty (30) days written notice.

All services rendered by Derek Cusick and Kelly Cash shall be billed by and paid to Tindell Symmes Estes and Cusick, PLLC.


