WHEREAS, THE CITY OF DIAMONDHEAD DESIRES TO FORMALLY APPOINT DEREK CUSICK AND KIMBER ROTEN TO SERVE AS CITY PROSECUTORS EFFECTIVE IMMEDIATELY AT A TOTAL MONTHLY RATE OF \$3,000;


