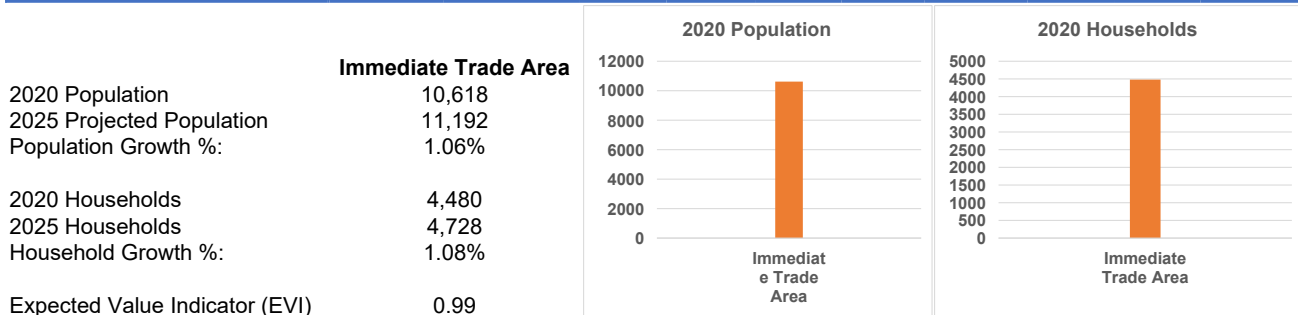

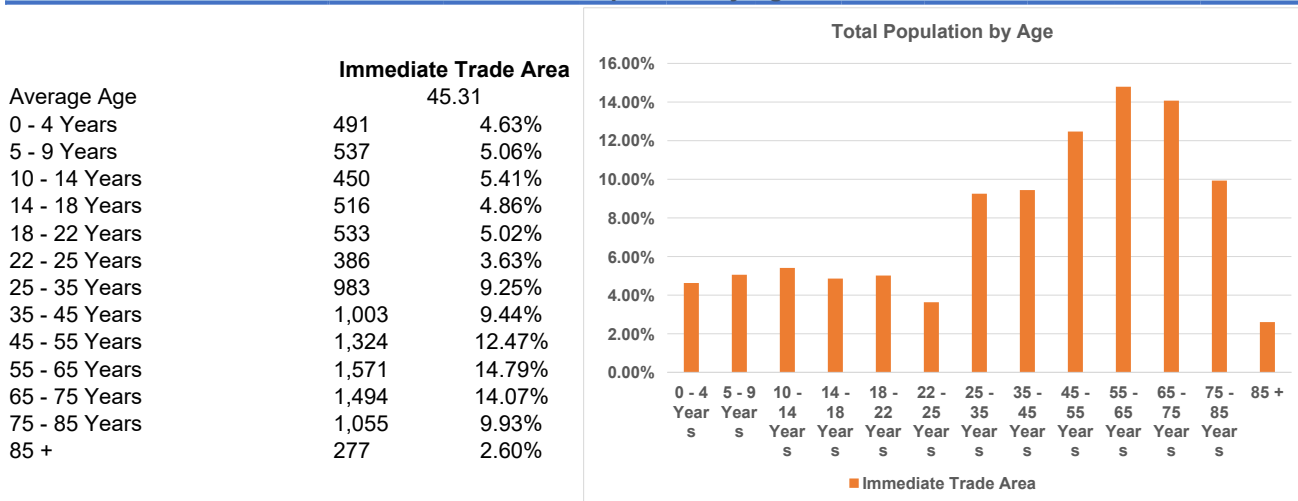

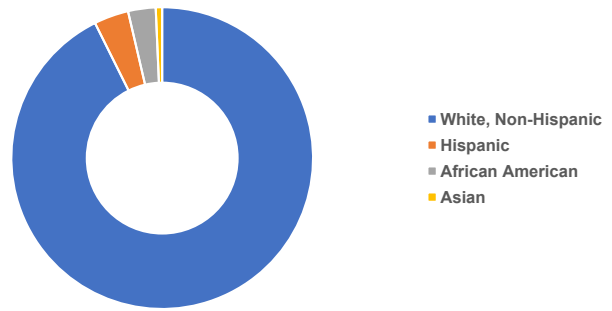


### Total Population by Age
