WHEREAS, the United States President Donald Trump on March 13, 2020 declared a national emergency in response to the COVID-19 pandemic and on March 14, 2020 Governor Tate Reeves declared a state of emergency in response;

WHEREAS, the declaration of emergency state tribes, territories, and the District of Columbia pursuant to section 501 (b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207 (the "Stafford Act"). State, Territorial, Tribal, local government entities and certain private non-profit (PNP) organizations are eligible to apply for public assistance; and

NOW, THEREFORE, BE IT RESOLVED, the Mayor and Council of the City of Diamondhead do hereby designate Michael Reso, City Manager, to serve as Applicant Agent and Jeannie Klein, City Clerk, to serve as alternate Applicant's Agent for COVID-19 (FEMA Disaster 4528).

SO BE IT RESOLVED, this the 21st day of April, 2020.




