Department of Transportation for the total project cost in the amount of \$12,533,013 with a federal share of \$11.279.712 the City of Diamondhead agrees to provide matching funds of at least ten percent (10%) or \$1.139.820.

<u>SECTION THREE:</u> Michael Reso, City Manager of the City of Diamondhead, is hereby authorized to publish any and all necessary notices as applicable in accordance with the guidelines governing the Better Utilizing Investments to Leverage Development (BUILD) Grant Program; and

Michael Reso, City Manager of the City of Diamondhead, is hereby **SECTION FIVE:** authorized to execute a grant offer and any other documents necessary to the acceptance and implementation of the program should the project be approved.
