

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DIAMONDHEAD MISSISSIPPI ACTING IN ACCORDANCE WITH SECTION 33-15-17 ORDER THE POSTPONEMENT OF THE SEPTEMBER 15, 2020 SPECIAL ELECTION IN THE CITY OF DIAMONDHEAD

WHEREAS, the City of Diamondhead called for a Mayoral Special Election scheduled for Tuesday, September 15, 2020 with polls operating from 7:00 a.m. to 7:00 p.m.

WHEREAS, a state of emergency was declared effective September 13, 2020 at 8:00 a.m. as the result of Tropical Storm Sally’s landfall projected path and increased intensity bringing inclement weather conditions to the immediate area; and

WHEREAS, the Hancock Emergency Management Agency has issued a mandatory evacuation for portions of Hancock County, including the areas in the City of Diamondhead south of Interstate 10, and

THEREFORE, pursuant to the emergency powers of the governing body in accordance with Section 33-15-17, Mississippi Code of 1972, and in order to preserve the safety and wellbeing of the residents of Diamondhead, the Mayoral Special Election scheduled for Tuesday, September 15, 2020 is hereby postponed to be rescheduled at the next meeting of the City Council.

Councilmember Clark moved, Councilmember Morgan seconded the motion to adopt the foregoing resolution, and the question being put to a roll call vote, the result was as follows:

The Governing Authority agrees to, shall be bound by, and otherwise be liable for, the terms and conditions of all such contracts, agreements, stipulations and orders. It shall be the responsibility of the Governing Authority to provide written notice to this Financial Institution should the authority of any of the agents it has so authorized to transact business on its behalf has been terminated. This Financial Institution shall incur no liability for acting in good faith upon the representations of said agents until such notice is properly given.
- (5) Any and all prior resolutions adopted by this Governing Authority and certified to this Financial Institution as governing the operation of the Governing Authority's account(s), remain in full force and effect to the extent not supplemented or modified by this authorization.
