MISSISSIPPI ADOPT AND IMPLEMENT A TAX INCREMENT FINANCING
REDEVELOPMENT PLAN**

WHEREAS, the City of Diamondhead, through its governing authority, on June 16, 2020 adopted and implemented a Tax Increment Financing Redevelopment Plan “hereinafter referred to as the Plan” as authorized for municipalities and counties by the legislature under Chapter 45 of Title 21, Mississippi Code of 1972 as amended; and

WHEREAS, the City of Diamondhead, has been advised that in order to maximize the benefits of said Plan, potential businesses and investors in the City would seek and benefit from a similar plan to be available through the County; and

WHEREAS, in order to encourage development and investment within the City and the County, the City of Diamondhead requests that the Hancock County Board of Supervisors adopt and implement its own Tax Increment Financing Redevelopment Plan to promote growth and economic development; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF DIAMONDHEAD, by and through its Mayor and City Council, that the Hancock County Board of Supervisors act upon this official request from to adopt and implement its own Tax Increment Financing Redevelopment Plan.
