RESOLVED, as it hereby resolved, the Mayor and City Council of the City of Diamondhead, Mississippi express its belief in the economic importance of the Tourism Industry to Hancock County, Mississippi by supporting the above mentioned to the enabling legislation of the Hancock County Tourism Development Bureau and requesting Legislative action during the 2014 Mississippi Legislative session year.
