RESOLUTION AUTHORIZING THE MAYOR AND CITY COUNCIL (THE "GOVERNING BODY") OF THE CITY OF DIAMONDHEAD, MISSISSIPPI (THE CITY), TO VACATE AND/OR ABANDON A DRAINAGE/UTILITY EASEMENT ALONG THE COMMON PROPERTY LINE BETWEEN LOTS 6 AND 7, DIAMONDHEAD SUBDIVISION PHASE 2, HANCOCK COUNTY LOCATED WITHIN THE CITY

WHEREAS, the Mayor and City Council (the Governing Body) of the City of Diamondhead, Mississippi (the City), acting for and on behalf of the City, hereby finds and determines as follows:

- 1. The City currently possesses a 5' drainage and utility easement on each side of the common property line between lots 6 and 7, Diamondhead Subdivision Phase 2, Unit 7A, Block 3;
- 2. George Fouts and Laurie Henry are the owners of lots 6 and 7, Diamondhead Subdivision Phase 2, Unit 7A, Block 3;
  - The physical address is 8938 Hanalei Circle. The ad valorem tax parcel numbers are 067J-3-36-048.000 and 067J-3-36-049.00. Construction and site plans and a building permit application have not been submitted for the construction of the addition.
- Comments from the Diamondhead Water and Sewer District reflect no water and sewer in the selected easements. Comments from the Diamondhead Public Works Department, Diamondhead POA and CEPA reflect selected easements are not needed (See attached comments).
- 4. Further, the City hereby abandons and/or vacates the drainage/utility easement as petitioned due to no apparent need for the drainage/utility easement. These drainage/utility easements are 5' drainage and utility easements on each side of the common property line between lots 6 and 7, Diamondhead Subdivision Phase 2, Unit 7A, Block 3 except the width of the 10' drainage easement of the front and rear property lines.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY, AS FOLLOWS:

SECTION 1. That the Governing Body of the City will hereby abandon the selected drainage/utility easements with respect to Lots 6 and 7 described in bullet #4.

SECTION 2. It is agreed and understood that George Fouts and Laurie Henry or their representative will be responsible for the filing of all necessary documents with the Chancery Clerk of Hancock County, Mississippi.
