

RESOLUTION OF THE CITY OF DIAMONDHEAD
APPOINTING A DEPUTY MUNICIPAL COURT CLERK

THE CITY DIAMONHEAD HEREBY BRINGS FORTH A RESOLUTION APPOINTING A DEPUTY MUNICIPAL COURT CLERK TO SERVE THE CITY OF DIAMONDHEAD PURUSANT TO MISS. CODE ANN §21-23-11 AND CONSISTENT WITH THE FOLLOWING:

WHEREAS, THE CITY OF DIAMONDHEAD IS AUTHORIZED PURSUANT TO MISS. CODE ANN §21-23-11 TO APPOINT A MUNICIPAL COURT CLERK, WHOM SHALL HAVE ALL OF THE POWER AND AUTHORITY THAT IS VESTED IN THE MUNICIPAL COURT CLERK;

WHEREAS, THE CITY OF DIAMONDHEAD DESIRES TO HAVE A DEPUTY MUNICIPAL COURT CLERK ASSIST THE MUNICIPAL COURT CLERK AND IN CASE OF THE MUNICIPAL COURT CLERK'S ABSENSE, REMOVAL, OR RESIGNATION, FULFILL THE MUNICIPAL COURT CLERK'S DUTIES AND OBLIGATIONS AS A INTERIM MUNICIPAL COURT CLERK;

WHEREAS, THE CITY OF DIAMONDHEAD DESIRES A CITY EMPLOYEE BE FORMALLY APOINTED AS DEPUTY MUNICIPAL COURT CLERK AND THAT THE EMPLOYEE'S RATE OF PAY SHALL REMAIN THE SAME;


WHEREAS, THE DEPUTY MUNICIPAL COURT CLERK SHALL ALSO HAVE OTHER DUTIES UNDER THE MANAGEMENT OF THE CITY MANAGER, THE DEPUTY MUNICIPAL COURT CLERK SHALL REMAIN UNDER THE MANAGEMENT OF THE CITY MANAGER, UNLESS OTHERWISE DETERMINED BY COUNCIL.


