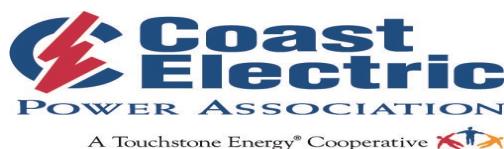

SAFE SUBSTITUTE is...

A SAFE ALTERNATIVE TO TOXIC PRODUCTS. FACT SHEETS ARE AVAILABLE ON EPA WEBSITE TO HELP REDUCE THE USE OF TOXICS AND MINIMIZE HEALTH RISKS.

PROPER DISPOSAL is...

EXTREMELY IMPORTANT. IT IS DANGEROUS - AND ILLEGAL - TO DISCARD HOUSEHOLD HAZARDOUS MATERIALS IN THE TRASH OR DOWN THE DRAIN. INSTEAD, USE UP THE PRODUCT AS INTENDED, OR TAKE THE UNUSED PORTIONS TO THE SCHEDULED

LEGAL TRANSPORTATION is...

LEAVING PRODUCTS IN THE ORIGINAL CONTAINERS, AND MAKING SURE THAT THE CONTAINERS ARE SEALED SO THAT THEY WILL NOT LEAK. TRANSPORT CONTAINERS IN THE TRUNK OR THE BED OF THE VEHICLE AWAY FROM PASSENGERS.

DO NOT TRANSPORT MORE THAN 5 GALLONS
OR 50 POUNDS AT ONE TIME.
